Each participant is responsible for the safety and liability of their own display and merchandise. CWB Events and the City of Reno assume no responsibility for loss or damage to merchandise, display, canopies or participants. Overnight security will be provided on Saturday evening. Show hours will be from 10:00 am to 5:00 pm on both days.

Booth fees are \$175.00 for a 10' X 10' or \$295.00 for 10' X 20' space, plus 10% commission on all sales. Corner spaces are \$25 additional. Please submit 3-4 images of your work and 1 image of your display, and a current Biography. Confirmation status will be sent via email. Booth fee includes \$15 for City Business License.
